## 2458. To receive report from Downham In Bloom Sub Committee

The Chairman of Downham In Bloom Cllr Daymond led members through the most recent set of minutes (Appendix 2) and advised preparations were continuing apace.

#### 2459. To discuss Platform One Café & Takeaway Premises Licence

Members were advised an application had been made for a new premises licence in respect of Platform One Café & Takeaway at the Railway Station and, whilst the Town Council are not a statutory consultee, the Borough Council do make all parishes aware of such applications.

Members noted the application was for the supply of alcohol both on and off the premises between the hours of 07:00 - 17:00 seven days per week. Members considered this was a reinstatement of a past facility and welcomed the enhancement of services provided at the station.

## 2460. To discuss Environment matters

The Deputy Mayor Cllr Groom raised three topics for discussion.

i) The protection of wildlife and their habitats, trees and hedgerows in relation to the land east and south of Denver Hill development.

It was agreed Cllr Hendry and her would attend the offices the following day to familiarise themselves with the associated planning conditions.

#### ii) Promotion of the Howdale

The Deputy Mayor commented she had noticed, following the Carnival day festivities, that many people had seemed unaware of the Howdale open green space area.

The Deputy Mayor undertook to raise the topic of the Borough Council installing brown fingerpost signage with Old Town Ward Borough Councillor Patel.

## iii) Cycle paths

It was commented this work is currently within the remit of the Network Improvement Strategy working party.
